## Begich Tax Fairness Bill for Tribes Becomes Law

### New Law Gives Alaska Tribes Same Tax Protections as State and Local Service Programs

The Tribal General Welfare Exclusion Act, a bipartisan bill cosponsored by U.S. Senator Mark Begich that passed the Senate last week, was signed into law today by President Obama. The legislation protects Alaska Native

tribes from unfair taxation by adding tribally administered programs to the Internal Revenue Service's (IRS) "general welfare exclusion."

"Because of this law, Alaska Native tribes and

tribes in the Lower 48 will now be treated fairly by the IRS and by the federal government," said Begich. "But we can't rest on our laurels. I will continue to use my seat on the Indian Affairs Committee to make sure this Administration lives up to the promises made to this nation's First People and the Alaska Native community."

The Tribal General Welfare Exclusion Act is supported by 20 tribal organizations including the Alaska Federation of Natives.

About the Tribal General Welfare Exclusion Act

The Internal Revenue Service (IRS) maintains a "general welfare exclusion" for state and local programs which cover a wide array

of government services like health services, public education, and affordable housing. As a result of this exclusion, these programs and services are not taxed. However, the IRS has routinely taxed these same crucial programs and services aimed to support the health and safety of Native families. Tribal governments oftentimes struggle financially to provide these additional programs, which often are part of the federal government's longstanding trust responsibility. The unwillingness of the IRS to include tribal programs under the "general welfare exclusion" puts an additional burden on tribes and their residents.

The Senate version, S. 1507, was introduced last

## Obama Administration Announces Climate Action Champions Competition to Recognize Climate Leaders Across the United States

New Competition will Showcase Local and Tribal Governments Taking Action to Cut Carbon Pollution and Build Resilience to the Impacts of Climate Change

The impacts of climate change are not just an issue for future generations—they are already being felt today. Communities across the country are on the front lines of climate change and are experiencing extreme weather events – from more severe droughts and wildfires to fiercer storms to record heat

waves. The past decade has been the hottest on record in the United States. Rising sea levels mean more powerful storm surges and flooded streets in places like Norfolk and Miami.

The Obama Administration is committed to taking decisive action to combat climate change. Today, the Administration announced a new Climate Action Champions competition that will identify, showcase, and invest in up to 15 local and tribal governments across the country that demonstrate an ongoing commitment to

cutting carbon pollution and preparing for the impacts of a changing climate. The competition will be administered by the U.S. Department of Energy (DOE), and will be implemented in collaboration with a broad range of Federal agencies.

The Climate Action Champions' dual focus on both mitigation of greenhouse gas pollution and building resilience to climate impacts at the local level makes this competition unique. By addressing these two goals together – for instance, by installing renew-

able energy on buildings in order to provide a reliable energy source for emergency responders; installing energy-efficient windows that are also more storm-resistant; deploying microgrid technology to bolster the resilience of critical infrastructure; or leveraging innovative green infrastructure for carbon sequestration and flood protection – the Climate Action Champions competition will help American communities to accelerate and expand their efforts at the nexus of



year by original sponsors Senators Jerry Moran (R-KS) and Heidi Heitkamp (D-ND), and co-sponsored by Begich. It will:

Mandate tribal government programs, services and benefits authorized or administered by tribes for tribal citizens, spouses and dependents are excluded from income as a "general welfare exclusion";

Clarify that items of cultural significance (e.g., paying someone to lead sacred Indian ceremonies) or cash honoraria provided by tribal governments shall not represent compensation for services and shall be excluded from taxable income;

Direct the Secretary of Treasury to require education and training of IRS field agents on federal Indian law and the unique legal treaty and trust relationship between the government and tribes;

Establish a Tribal Advisory Committee within the Treasury to advise the Secretary on matters of

Indian tax policy;

Temporarily suspend all audits and examinations of tribal governments and members until the education and training measures are completed;

Authorize the Secretary to waive any penalties or interest imposed on Indian tribal governments or members; and

Direct the Secretary that any ambiguities in applying this Act shall be resolved in favor of tribal governments and deference shall be given to tribal governments for the programs administered and

authorized by the tribe to benefit the general welfare.

In July, companion legislation, H.R. 3043, was introduced in the U.S. House of Representatives by Rep. Devin Nunes (R-CA22). The House passed H.R. 3043 on September 16 and the Senate passed it September 18.

carbon pollution reduction and climate resilience.

In addition to being recognized as climate leaders, the designated Champions will receive technical assistance to bolster their current and planned actions around carbon pollution mitigation and climate resilience. Each of the selected communities will be assigned a coordinator to help them leverage existing Federal programs and resources to support the implementation of their climate strategies; and, in certain competitive federal grant programs, the Champions will receive a preferred status – helping them develop new approaches, identify new synergies, forge new partnerships, and surface gaps in what we know. The Champions will have the opportunity to engage in peer-to-peer learning with other communities throughout the country and to showcase their efforts on the national stage. Some specific examples of the Federal support that will be offered to the winning communities include:

- **Data from Decision-making:** Champions will be provided with climate data and tools that are tailored to their communities – including validated climate science, data, vulnerability assessments, and risk projection tools needed to make smart planning decisions – and they

will be given technical assistance to help them make smart climate adaptation decisions. This support will be provided through programs within the National Oceanic and Atmospheric Administration (NOAA), U.S. Department of the Interior (DOI), the U.S. Department of Agriculture (USDA), and the Federal Emergency Management Agency (FEMA), among others.

- **Peer Network:** Champions will be invited to join the peer network of the Administration's Partnership for Sustainable Communities, which brings together communities that have experience with long-range planning to strengthen environmental protection, economic competitiveness, and climate resilience. As part of the network, Champions will be invited to regional roundtables to discuss their projects. They will also receive access to data and tools that the Partnership has designed.
- **Emergency Response Exercises:** Champions will have the chance to participate in tabletop exercises offered by FEMA, in which

participating communities will assess their preparedness for and resilience to extreme weather events.

• **Access to Renewable Energy Experts:** DOE's SunShot Initiative will work with Champions through two programs. First, the Solar Outreach Partnership will help Champions to accelerate solar energy adoption at the local level through a mix of educational workshops, peer-to-peer sharing opportunities, research-based reports, and online resources. Second, the Solar Technical Assistance Team at the National Renewable Energy Laboratory (NREL) will bring together solar experts to provide Champions with unbiased information on solar policies and issues in order to facilitate the development of a market for solar photovoltaic technologies.

- **Tribal communities designated as Champions** will be offered the chance to participate in the Strategic Technical Assistance Response Team (START) program, which is an in-depth technical assistance program designed to help develop renewable energy projects. This year, the

START program will emphasize working with tribes on energy system resilience.

- **Resilience Partnership with Federal Facilities:** Where possible, Champions will be able to participate in new preparedness pilots that are designed to pair local or tribal communities with Federal partners to assess expected local climate impacts and develop plans to address them cooperatively. These would be modeled after two pilots that President Obama announced on July 16, in which the City of Houston will work with the National Aeronautics and Space Administration's (NASA's) Johnson Space Center and the State of Colorado will work with NREL.
- **Technical Assistance and Coaching:** Champions may be eligible to receive technical assistance and support from the National Resource Network, including participation in its structured peer network events and learning conferences, coaching support through its 311 for Cities feature, and access to its extensive information resources and database on existing technical assistance opportunities.

Today's application will open the first round of the Competition, seeking a geographically and economically diverse set of communities that are already leaders in addressing and preparing for climate change. The next round of the Competition will seek communities that have shown a strong commitment and motivation to address climate change but that have not had the resources to make substantial investments to date. The pioneering Champions will be asked to mentor and share lessons learned with the communities selected in the next round, helping them to leapfrog common implementation challenges and creating a model for future Champions to follow.

The Administration has long recognized and encouraged leadership by state, local, and tribal governments to address climate change. In December 2013, DOE and the U.S. Department of Housing and Urban Development (HUD) launched the Better Buildings Accelerators to support efforts led by state and local governments to cut energy waste and eliminate market and technical barriers to improving building efficiency.

Today's announcement builds on the President's Climate Action Plan, which includes a comprehensive set of measures to reduce carbon pollution, promote clean energy, protect communities from the impacts of climate change, and lead on the international stage.

Today our people, the Lhaq'temish or People of the Sea, navigate the same waters our ancestors crossed to fish and share the lessons of survival, culture and history. We have worked, struggled and celebrated life on the shores and waters of our homeland for thousands of years. In 1855, our leaders signed the Point Elliott treaty which resulted in the ceding of some of our homelands to the U.S. government. This reserved existing inherent rights to hunt, fish and gather throughout our usual and accustomed grounds, stations, traditional territories and homeland territory and includes our present-day reservation. Our past lead-

ers, seeing the encroachment on our lands and way of life, had the foresight to fight to preserve the lifeblood of the Lummi people — our right to fish. As the largest native fishing fleet in the nation, with approximately 700 registered fishers, we have exercised these rights and continue to defend and protect them to this day.

The decisions we make ensure that our Schelangen, our way of life, lives well beyond us. It was unimaginable to our ancestors that there would come a time when the salmon runs were not thick and teeming with enough fish to feed the village through every season. Today, the salmon are far fewer and our community is forced to deal with a changing landscape, and new environmental dangers and challenges.

The Lummi Nation, as a self-governing and sovereign nation, is committed to our responsibility to the land, economy and community, both now and

for future generations. We believe in a thriving and healthy community for everyone.

That's why the Lummi Nation will continue to oppose a new coal export terminal at Cherry Point on our traditional homelands. It poses too great a risk to the salmon, fish and shellfish that we as Lummi harvest annually and an integral piece of our culture and way of being. Increased vessel traffic will interfere with fishing, and the proposed terminal and increased uses of anchorages will reduce access to fishing grounds. The large volumes of ballast water discharged by Cape-sized ships that would call on the terminal threaten to introduce invasive species that could destroy the fishery. And carbon balance impacts caused by burning coal will contribute to ocean acidification that threatens all North Sound fisheries.

Our sacred duty to protect the salmon and people is also why we are proceeding with great caution in

conversations about the right path forward for the clean up of Bellingham Bay. The potential impacts on the ability to fish are not only critical to examine but required. Any activity, construction or changes in our shared waters and shorelines must protect the treaty fishing rights guaranteed us as a sovereign nation.

We are also partners and stewards in ensuring the health of our natural resources. We have created a wetland mitigation bank — an innovative means to ensure no net loss of wetlands or their functions, and to protect shellfish habitat and help restore salmon species. The bank allows individuals, governmental agencies and private companies, both Lummi and non-Lummi, to purchase credits to offset any unavoidable impact to our region's wetlands.

Among the many notable items from the last month, in my opinion, the most promising news is the recent development in our Ninth Circuit U&A

case. The judges' panel received a request from our Sklallam cousins to reconsider the decision to remand the case. At the time that this publication went to print the judges' panel denied that request. What that means for our community is that by October 7th, 2014 the Ninth Circuit will have filed mandate detailing the next steps of the court proceedings. In that mandate it will most likely explain the process re-opening our southern waters. In the meantime, as I have consistently done, I will call on the Sklallam leadership to find a solution outside of the federal court system.

As Lummi people, we are culturally linked to the waters, land and fish of our home. Our leaders have always created a path forward of subsistence and sustainability. They held sacred their duty to preserve our Schelangen, our way of life, for generations to come, and it's a duty we continue to hold sacred through all the changes of our modern world.

## From the Office of the Vice Chair

Fall is in the air again Lummi Nation. The days are growing noticeably shorter and the temperatures at night have begun to drop. The new school year has begun. We hope that everyone who had received a gift card for school clothes was able to find some great deals for their children. We've been very busy here in the Office of the Vice Chair.

As part of our efforts towards Health and Wellness, we teamed up with Reatha Tom and Anna Leigh from the Lummi Fitness Center in preparing for the 2014 Bellingham Bay Marathon over the

course of this past month. There was a great turn out this year. We were able to place a pair of the gorgeous Reef Net canoes in the Wexliem building, which was the starting point for the marathon along with an information table allowing folks participating in the marathon to get a glimpse of our traditional way of fishing. The route of the marathon ran from the Wexliem, around and down the entire length of Lummi Shore Rd with the north bound lane closed off to traffic, hung a left onto Kwina and past the Lummi Fitness Center where LIBC held a water station. It then continued on Kwina and turned right going down the Haxton Trail where it connected with Lummi Shore again. It then looped past Silver Reef Casino, down Slater Rd. continuing down Ferndale Road and then followed Marine Drive into Bellingham. The finish line was located at Depot Market Square on Railroad Ave in downtown Bellingham. The Finish Line Festival was a blast as well. Great job to all those involved in hosting the leg

of the marathon that took place on Lummi land and to all of those who walked or ran in the marathon. The Office of the Vice Chair was excited to have been able to sponsor one of the water stations to help the runners and walkers stay hydrated while they competed in the marathon. We would like to raise our hands and say Hy'shqe to the Lummi Police Department and to Lummi TERO for allowing two of their officers and four flaggers to aid in the guidance of traffic and the safety of all the participants while within the reservation boundaries.

The Office of the Vice Chair played a role in the recent evaluation of the LIBC Judicial System performed by Joanne Cook and Holly Thompson. Their goal is to complete a review of our system to identify strengths in our current system and to provide recommendations for areas that can be improved. Joanne Cook, a member of the Grand Traverse Band of Ottawa and Chippewa Indians has fourteen years experience working as a

tribal court judge and has been involved in the development of two alternative courts; Peacemaking and Healing to Wellness Court. She has also been a facilitator and trainer on peacemaking topics for several organizations. Hon. Holly K. Thompson is a descendant of the Yaqui/Apache/Tarascan/San Felipe Pueblo tribes and the English Isles. She has served as a Hearing Officer for Chicago Public Schools, a Guardian ad Litem for Cook County Public Guardian's Office. She soon moved into private law practice. Hon. Thompson then became Vice President of the Native American Foster Parents Association after which she founded and served as Vice President and then President of the Illinois Native American Bar Association. How impressive. But she doesn't stop there. She then served as acting Chief Judge/Associate Chief Judge for the Grand Traverse Band of Ottawa and Chippewa Indians and then became an Associate Supreme Court Judge for the Nottawaseppi Huron Band of Potawatomi Indi-

ans.. She has also served on boards and committees, authored legal publications, provided trainings for organizations, and currently serve as a pro-tem Appellate judge for a number of tribes. We anxiously await the results of their review of our judicial system. It goes without saying that the Office of the Vice Chair staff feel that we are all in good hands, given the experience of both Joanne Cook and Holly Thompson.

In other news, as some of our community members may already be aware, each year LIBC is required to contribute a set percentage of revenue brought in by the Silver Reef Casino to organizations throughout Washington State, both Tribal and Non-Tribal. This is a requirement in the Gaming Compact that LIBC has with the Tribal Gaming Association. There are five separate categories of organizations that we are required to donate to:

- Community Contribution: funds that can be distributed to non-tribal local

governmental agencies, for reimbursement for actual or potential impacts from Class III gaming activities. (I.E. Police and Fire Departments, etc.)

- Charitable Donations: funds for non-tribal bona fide nonprofit and charitable organizations in the State of Washington. Non-tribal meaning it cannot be owned by the Lummi government. Other Tribes who have bona fide nonprofit or charitable organizations are eligible to petition for funds. Lummi Nation controlled programs are not eligible for these funds. Non-profit letter must be submitted for proof of status. (These are Non-Profit organizations that can be tribal or non-tribal,

they just cannot be Lummi organizations)

- Community Impacts: These funds are for tribal governmental programs that promote the tribe and its members to become self sustaining. (These are programs, departments, etc. that can belong to LIBC.)
- Problem Gambling: funds dedicated to problem gambling education, awareness, and treatment in the State of Washington. Lummi Nation programs can petition for these funds.
- Smoking Cessations: funds dedicated to smoking cessation, prevention, education, awareness, and treatment in the State of Washington. Lummi Nation programs can petition for these funds.

They had an amazing time being able to share their stories and experiences of sobriety with so many others from other tribes all around the state. Community member Alvin Cultee did a great job MC'ing for the Pow Wow and our hands go up to him.. ## General Manager's Corner

### Family Services Department

The General Manager supported the appointment of Michelle Vendiola as the new Interim LYA Executive Manager at the Lummi Youth Academy. The Family Services Director has assisted in the transition in fostering a positive relationship with staff and strengthen the residents needs. There have been recent changes in the operation strategy to realign team based service approach as the new operation standards are being implemented.

Lummi Senior Program is moving forward with scheduling meetings with LBC residents to complete new lease agreement with an approved communication plan, staff support for review efforts and a written Senior Program letter of explanation. The new pol-

icies and procedures were presented to the Family Service and Health Commission for consideration. The new lease will be issued on October 1, 2014, although few transitions have been completed for some of the residents. This is a change from Housing Authority issuing the leases in years past. This new lease is a result of a recent LIBC decision to transfer management of Little Bear Creek Center from Lummi Housing Authority to the Lummi Family Services department. Thank you Jackie Ballew for your energy and being instrumental to complete the new policy development and approval by the FS & H Commission.

Lummi Family Services, Veterans and the Facility Manager completed a draft Veteran Facility Renovation plan and detailed cost analysis to the H&FS Commission representative

for 2014 budget amendment consideration. Phase I of the renovation cost is estimated at \$70,000.

The Family Services Department and Senior Program Manager submitted a draft Little Bear Creek Elderly Center Independent Living program policy to H&FS Commission for consideration. This policy is addressing a long standing issue with regard to whether the Little Bear Creek Elderly Center is an assisted living facility or an independent living facility. The General Manager has instructed development of this policy for better communication and understanding by the residents and the community that the current facility is an independent living facility.

### Records and Archives

Over the summer the Records and Archives were very active to ensure that records are retrieved and stored properly in the archives. The 2014 Resolutions were scanned and certified, Resolutions were added to H:drive for electronic access by the departments. There were 45 file requests from various departments from Records and Archives: 24 files requests from courts, 7 file requests from Clinic, 5 file requests from Lummi Housing Authority, 3 files request from Child Support, and 1 file request from

LNS.

There were 41 files returned: 4 files returned from courts, 2 file returned from Human Resources, 1 file returned from Public Defenders, 12 files returned from Lummi Housing Authority, 1 file return from Child Support, and 3 file returns from Prosecutors Office.

The department continues the records scanning project without the use of a large scanner at the old Archives building. The infrastructure of the old archives building is still being worked on for new phone and computer lines.

Once again, the department is encouraging all departments to submit pictures to make copies of birth announcements, death certificates, wedding photos or invitations, graduation announcements or photos, sporting events, class pictures, yearbooks or annuals, naming, etc. to begin or add to your family history. If any department needs to schedule an appointment with Records and Archives to assist with the record scanning process, the department requests that scheduling is needed.

### Enrollment Department

The Enrollment Office's goal is to collect, maintain

and update the Lummi Tribal Roll with the intent of preserving direct family history. Lummi enrollment is a direct service to Lummi People and LIBC Departments.

There are 3 staff members: Vela K. Kamkoff, Director, Christine Cultee, Records and Patrick W. Jefferson, IT services.

During this reporting cycle, community outreach was implemented to those un-enrolled to update the files. There were 14 babies born in 2014 of which 5 are enrolled and 2 files pending. Scanning is a priority project to enter all pertinent documents into enrollment software. Old files continue to be scanned and new files are scanned as they receive them.



### Human Resources

The Human Resources operation continues to provide support in the technical learning process for implementation of the new Kronos System (Electronic Time Keeping System for the LIBC employees).

The department continues to support operation departments on its personnel management issues in addressing technical questions. The Human Resource policy workgroup continues to meet and addressing ongoing policy concerns. Some of the pol-

Look at the eagle, kwe-elengsen. He is thinking about his next meal. He wastes no time. He is patient. He looks; he observes. He soars in the sky, searching from afar, deep in thought, his eyes on his goal. He doesn't waste his time fooling around.

You have the potential to do whatever it is you want to do in your life, to

make changes, to get yourself on a new path.

One might say, “Well, you don't know what happened to me, you don't know what it's like to be in my shoes, you don't have my obstacles in your life, you don't have my health issues or my problems, my worries...”

Letting go of all the painful yesterdays and focusing on today helps us find peace in our lives and lets us achieve our goals. Each day is a new day.

So, now, again, what is it you want in your future? Think about that. We attract to us that what we think about. If it is not in your mind, it will not be in your future. Get your thinking right! Breathe. Let go of yesterday. It is gone. Today is your new day!

Lummi Counseling

Services has counselors who can help you develop new coping strategies so you can move forward. Lummi Behavioral Health has counselors who are there who can listen and hear your story so you can let it go and move on with your life. The fancy word is psychotherapy but it is really ‘talk therapy...’ The client talks, the counselor listens. There is no judgment.

## Whats in your kit?

Submitted by Adrienne Hunter. Former Disaster Preparedness Committee member at USIT.

An emergency or disaster supplies kit is simply a collection of basic items your household may need in the event of an emergency.

Try to assemble your kit well in advance of an emergency. You may have to evacuate at a moment's notice and take essentials with you. You will probably not have time to search for the supplies you need or shop for them.

You may need to survive on your own after an emergency. Local officials and relief workers will be on the scene after a disaster, but they cannot reach everyone immediately. You could get help in hours or it might take days. Additionally, basic services such as electricity, gas, water, sewage treatment and telephones may be cut off for days or even a week, or longer. This means having your own food, water and other supplies in sufficient quantity to last for at least 72 hours.

Your supplies kit should contain items to help you manage during these outages. Include items that you may use every day to

live independently such as prescription medicines, diabetic supplies, food for special diets, hearing aids and batteries, durable medical equipment and other assistive technology devices, and consumable medical supplies.

No idea where or how to start building your kit? Don't worry. We have you covered. Download our recommended list of supplies to get you started!

### Emergency Supply List

Additional items to consider adding to an Emergency Supply Kit:

- Prescription medications and glasses
- Infant formula and diapers
- Pet food and extra water for your pet
- Important family documents such as copies of insurance policies, identification and bank account records in a waterproof, portable container
- Cash or traveler's checks and change
- Emergency reference material such as a first aid book or information can be found at: [www.ready.gov](http://www.ready.gov)

- Sleeping bag or warm blanket for each person. Consider additional bedding if you live in a cold-weather climate.
- Complete change of clothing including a long sleeved shirt, long pants and sturdy shoes. Consider additional clothing if you live in a cold-weather climate.
- Household chlorine bleach and medicine dropper – When diluted nine parts water to one part bleach, bleach can be used as a disinfectant. Or in an emergency, you can use it to treat water by using 16 drops of regular household liquid bleach per gallon of water. Do not use scented, color safe or bleaches with added cleaners.
- Fire Extinguisher
- Matches in a waterproof container
- Feminine supplies and personal hygiene items
- Mess kits, paper cups, plates and plastic utensils, paper towels, toilet

tissue. Even aspirin, Ibuprofen, Tylenol...

- Paper and pencil
- Books, games, puzzles or other activities for children

Being prepared is almost like getting ready to go camping. You need to think of everything.

### Recommended items to include in a Basic Emergency Supply Kit:

- Water, one gallon of water per person per day for at least three days, for drinking and sanitation
- Food, at least a three-day supply of non-perishable food
- Battery-powered or hand crank radio and a NOAA
- Weather Radio with tone alert and extra batteries for both Flashlight and extra batteries
- First aid kit
- Whistle to signal for help
- Dust mask, to help filter contaminated air and plastic sheeting and duct tape to

shelter-in-place

- Moist towelettes, garbage bags and plastic ties for personal sanitation
- Wrench or pliers to turn off utilities
- Can opener for food (if kit contains canned food)
- Local maps
- Then what about a camping tent if you have one. A portable cook stove with little propane tanks for cooking. Or even your barbeque grill would work...

Note: Our people were survivors and they prepared for winter. They had no grocery stores, they had no electricity. If a severe disaster occurred, the government would be overwhelmed, we would need to take care of ourselves the best we can.

Our early people stored up food, our grandparents used to can food, smoke and salt fish, to put up for use in the winter to meet their needs. So, now, what can you do to help care for yourself and your family? [The Commodities program needs to be commended for teaching canning fish!!!]

## Felons and Voting Rights

If you were convicted of a felony in Washington State, your right to vote is restored as long as you are not under the authority (in prison or on community custody) of the Department of Corrections (DOC). Once your right is restored, you must re-register to vote in order to receive a ballot.

If you have questions about your status with DOC, you can call (800) 430-9674.

Restoring your right to vote

If you were convicted of a felony in a Washington State court, your right to vote is restored unless you are currently under the authority of DOC (in prison or on community custody). If you have questions about whether you are on community custody, call DOC at (800) 430-9674.

If you were convicted of a felony in another state or in federal court, your right to vote is restored as long as you are not currently incarcerated for that felony.

Once your right to vote is restored, you must re-register in order to receive a ballot. You can re-register online with MyVote, by mail, or in person.

You do not lose the right

to vote for a misdemeanor conviction or a conviction in juvenile court.

Three times a year, the Secretary of State uses information provided by DOC and the state court system to screen the list of registered voters for ineligible felons. If you are registered to vote, but are ineligible because of a felony conviction, you will be sent a letter explaining that your registration will be canceled in 30 days. The letter provides information on how to dispute the cancellation (RCW 29A.08.520).

Maintaining your right to vote

Do not commit another felony.

If you have willfully failed to make three payments in a 12 month period, the prosecutor can request the court to revoke your voting rights. If you show you have made a good-faith effort to pay, your voting rights can be restored by the court.

To challenge a voter registration, you must file a Voter Challenge with the county elections department where that person is registered.



## Are you trapped inside a life of abuse or know someone that is?

You try to do everything in your power to stop their abusive behavior. Nothing has worked because they don't want to stop controlling you and abuse is a method of doing it.

Stop and take a look on what has happened to you over the days, weeks months and years. Your efforts of trying to stop the abuse and to resolve the issues has made you feel as if you lose confidence in yourself and your abilities to stop the abuse. The abuse strips away your self confidence, self esteem and destroys your self-worth. You become fearful, insecure and dependent. Everything in your life revolves around the abuser.

### Does this sound like you or a loved one?

As much as we try we will not change the abuser. You cannot love them enough to make them stop abusing you. Only they can change themselves or make the decision to stop being abusive.

Domestic violence and abuse can happen to anyone and a problem that is often overlooked. It does not discriminate. Abuse comes in all genders, shapes, sizes, colors, economic class, sexual orientations and personality types.

We need to educate ourselves of the signs of an abusive relationship. No one should live in fear of the person they love. We need to work together to end Domestic Violence and abuse by knowing and recognizing the warning signs. These behaviors are not our traditional ways.

Domestic abuse, also known as spousal abuse, occurs when one person in an intimate relationship or marriage tries to dominate and control the other person.

### Are you, our someone you know being abused?

There is no way to tell for sure if someone is in a domestic violence re-

lationship. Most people experiencing relationship violence do not tell others what is going on with them.

How do you tell if someone is being abused?

### General warning signs of domestic abuse

#### People who are being abused may:

- Seem afraid or anxious to please their partner
- Go along with everything their partner says and does
- Check in often with their partner to report where they are and what they're doing
- Receive frequent, harassing phone calls from their partner
- Talk about their partner's temper, jealousy, or possessiveness

#### Warning signs of physical violence

- People who are being physically abused may:
- Have frequent injuries, with the excuse of "accidents"
- Frequently miss work, school, or social occasions, without explanation
- Dress in clothing designed to hide bruises or scars (e.g. wearing long sleeves in the summer or sunglasses indoors)

#### Warning signs of isolation

People who are being isolated by their abuser may:

- Be restricted from seeing family and friends
- Rarely go out in public without their partner
- Have limited access to money, credit cards, or the car

#### The psychological warning signs of abuse

People who are being abused may:

- Have very low self-esteem, even if they used to be confident
- Show major personality changes (e.g. an outgoing person becomes withdrawn)
- Be depressed, anxious, or suicidal

What can you do to help a friend or family member that is in an abusive relationship?

Educate yourself about domestic violence and where help is available or contact Lummi Victims of Crime at 360-312-2015. All services are free and confidential. If someone is in immediate danger, call 911. Men can also be victims of domestic abuse; Lummi Victims of Crime can provide assistance and support to them, as well.

Respect that your family or friend may still love their abuser and they believe their abuser may change. Do not tell them what to do; they know what is best for them now. Ask what they want to do.

Listen to what they have to say and respect their privacy. Inform them that you are concerned about them.

Avoid labeling, threatening or criticizing the abuser. The victim holds onto the past that the abuser was once loving and caring towards them.

Understand that there are valid reasons for staying—such as the threat of worse violence, harm to pets or family members, lack of financial resources, fear of homelessness, the belief of not being able to cope alone or feeling responsible for making the relationship work.

Acknowledge the victim's strengths and abilities when it is appropriate. The abuser may be very critical and never offer compliments or show appreciation.

Recognize that the abuser may try to main-

tain control by isolation and intimidation. Offer to be available to listen when there is a need to talk.

Encourage her or him to contact Lummi Victims of Crime to speak with an advocate. The 24 Hour Crisis Line phone number is (360)312-2015. All services are free and confidential.

#### Making the decision to leave

If you're trying to decide whether to stay or leave, you may be feeling confused, uncertain, frightened, and torn. One moment, you may desperately want to get away, and the next, you may want to hang on to the relationship. Maybe you even blame yourself for the abuse or feel weak and embarrassed because you've stuck around in spite of it. Don't be trapped by confusion, guilt, or self-blame. The only thing that matters is your safety.

#### If you are being abused, remember:

You are not to blame for being battered and mistreated

- You are not the cause of your partner's abusive behavior
- You deserve to be treated with respect
- You deserve to be happy.
- Your children deserve a happy and safe life.
- You are not alone. There are people waiting to help.

Whether or not you're ready to leave your abuser, there are things that you can do to protect yourself. These safety tips can make the difference between being severely injured or killed and escaping with your life.

#### Prepare for emergencies

Know your abuser's red flags. Once you sense trouble brewing come up with a believable reason to leave the house.

Identify safe areas in

the house. Know where to go if your abuser attacks or starts and argument.

Come up with a code word that your children, family, friends, co-workers and neighbors know that you're in danger and the police should be called.

#### Make an escape plan


Be ready to leave at a moment's notice. Have emergency cash, clothing and important numbers and documents stashed in a safe place.

Practice escaping quickly and safely by rehearsing your plan so you know exactly what to do if you are being attacked by your abuser. Have the children practice the escape plan also.

Memorize a list of emergency numbers, such as domestic violence hotline or emergency contacts.

When you are ready to leave an abusive relationship, there are certain things you must keep in mind. First of all, the ultimate decision is going to be made by YOU. No one else can force you. The desire must come from deep within yourself, and you must gain strength from this, even if it's just spiritual strength. What you need to do is assemble an emergency plan, obtain counseling, and plan your exit. You can call Lummi Victims of Crime at 360-312-2015 about the shelter or other resources or the National Domestic Violence Hotline at 1-800-799-7233 (USA) to find out about other shelters. This gives you a place to go to provide support and safety for you and your family.

If you suspect that someone you know is being abused, speak up! If you're hesitating—telling yourself that it's none of your business, you might be wrong, or the person might not want to talk about it—keep in mind that expressing your concern will let the person know that you care and may even save his or her life.



## Natural Resources Department

### Natural Resources Team

Natural Resources staff want to thank the Commodity Food Department for challenging us to the tug-o-war at the LIBC picnic. We would also like to wish them better luck next time!

### Water Resources Division

The Water Resources Division staff continued the surface and ground water ambient water quality monitoring activities on the Reservation, reviewed storm water pollution prevention plans and conducted associated inspections for several tribal development projects, conducted site visits to evaluate proposed projects as part of the Lummi land use permit process, and continued the development and maintenance of several databases.

On September 8, an outreach letter was mailed to all residences on the Reservation that are located in the Nooksack River floodplain or coastal flood zones. The letter contains important information about how to stay safe during a flood, what you can do to reduce potential flood damages to your home, how to obtain flood insurance, and free services that the Natural Resources and Planning departments provide to help residents prepare for and recover from flood events. The letter is also available at the Lummi Natural Resources Department website (<http://lnnr.lummi-nsn.gov/LummiWebsite/Website.php?PageID=79>) under the section titled "National Flood Insurance Program (NFIP) and Community Rating System (CRS)." Additionally, Division staff recently completed the Annual Flood Damage Prevention Plan Progress Report for the Lummi Nation. The report can be found at the above website under the section titled "Flood Damage Reduction Plan."

On September 9-10, Kara Kuhlman attended the 5th Annual Pacific Northwest Climate Science Conference at the University of Washington campus. Kara is currently developing a climate change impacts assessment for the Reservation, which should

be completed by the end of the year.

Merle Jefferson, Leroy Deardorff, Frank Lawrence III, Victor (Turtle) Johnson, and Jeremy Freimund met in Olympia with senior representatives from the EPA and Washington's Governor's Office, Ecology, Department of Health, and the Department of Agriculture to discuss the response to the high fecal coliform levels in Portage Bay and the pending closure of a portion of tribal shellfish beds. The Lummi Nation has voluntarily closed approximately 45 acres of growing area (see related story and map) because the fecal coliform levels currently exceed federal

water quality standards for commercial shellfish beds.

Frank Lawrence III, Gerry Gabrisch, a contractor, and Tyson Waldo of the Northwest Indian Fisheries Commission began conducting the annual monitoring of the Phase 1A Site of the Lummi Nation Wetland and Habitat Mitigation Bank. Monitoring of the willow planting areas is now complete and monitoring at the conifer planting areas will begin in October.

Turtle Johnson started his fall quarter classes at Western Washington University, which began on September 24. Turtle's goal is to graduate with a


Bachelor of Arts (BA) in Environmental Policy in the 2015/2016 school year.

The Water Resources Division partnered with the Environmental Protection Agency (EPA) and the U.S. Coast Guard to provide a 24-Hour HazMat and Oil Spill Awareness Course for tribal officials on September 24-26, 2014 at the Silver Reef Hotel, Casino & Spa. Participants learned the basic skills needed to assist in responding to a hazardous materials and/or oil spill incident, including health/safety, basic chemistry, use and types of personal protective equipment, agency responsibilities and resources. Additional skills


taught included information related to integrating tribal responsibilities into the Incident Command System (ICS) pursuant to the Northwest Area Contingency Plan (<http://www.rrt1onwac.com/nwacp/>).

### Geographic Information Systems (GIS) Division

The Lummi Geographic Information Systems (GIS) Division staff worked with Water Resources Division staff to delineate the shellfish harvest closure area in Portage Bay. The area currently closed to harvest can be seen in the adjacent map. A press release describing the closure is also published in this issue.

## Portions of Portage Bay shellfish beds closed to harvest

### *Deteriorating Marine Water Quality Leads to Shellfish Area Downgrade*

BELLINGHAM-- In consultation with the Washington Department of Health, the Lummi Nation has proactively and voluntarily closed 335 acres of Lummi shellfish beds in Portage Bay to ceremonial, subsistence, and commercial harvest after federal bacterial standards for commercial shellfish harvest were recently exceeded. The degraded water quality is attributed to fecal matter primarily from livestock, humans and pets. The fecal coliform bacteria indicate that there may be pathogens absorbed by the shellfish that make them unsafe to eat.

After nearly 10 years of being unable to harvest from the Lummi Nation's usual and accustomed shellfish areas in Portage Bay, the area was re-opened for commercial and subsistence harvesting in 2006. In the years prior, successful community efforts to adopt livestock management practices to reduce discharge of manure into waterways and to monitor water quality and correct pollution problems led to the re-opening.

Lummi Nation Chairman Timothy Ballew II, stated "The closure of our shellfish beds is a terrible development and must be responded to. We have learned the detrimental impacts this will have on our people from the last decade-long closure between 1996-2006. Our community relies on the opportunity to harvest seafood both for commercial and subsistence purposes. When that opportunity is taken away our community suffers. Over the last two years, in addition to the implementation of policies that were intended to protect the shellfish, the Lummi Nation invested general fund dollars into planting clam seed to increase the cultivation of our harvesters. If the problem is not fixed that effort is compromised. Failure of our upstream partners to follow the policies developed to respond to the last closure has led to this disaster. Immediate

actions are needed to right the problem. We are committed to doing the work required that will reopen the shellfish beds."

"This current downgrade is really disappointing because the agricultural community, individuals, the Lummi Nation, and local, state, and federal agencies collaborated on finding and correcting pollution problems that caused the 1996-2006 closure," said Merle Jefferson, Lummi Natural Resources Department Director. "I remember when the Portage Bay shellfish beds were re-opened in 2006 with great fanfare – unfortunately, community members have not maintained their efforts. As a result, tribal members who did not pollute the water nevertheless have to suffer the consequences of actions or inactions of our upstream neighbors."

"This closure is devastating for the approximately 200 families on the Lummi Reservation who make their living harvesting shellfish," added Jefferson. "During the last 10-year closure, the tribal community lost an estimated \$8.5 million in revenue. In addition this affects as many as 5,000 Lummi tribal members who rely on this shellfish area for subsistence and cultural purposes."

"The EPA shares the Lummi Nation's concerns about the unacceptable condition of shellfish growing waters in Portage Bay", said EPA Regional Administrator Director Dennis McLerran. "EPA is providing significant funding for fecal coliform reduction programs as well as conducting compliance activities in the watershed. We are committed to work with the Lummi Nation, state and local governments, and others to achieve sustained improvements in water quality."

"Reducing fecal bacteria pollution to achieve water quality standards in Whatcom County's waterways and marine waters is

a high priority for us," said Doug Allen, Manager of Ecology's Bellingham field office. "We will continue to work closely with partners and community members to identify and correct pollution sources."

Ginny Prest, Dairy Nutrient Management Program Manager for the Washington State Department of Agriculture said, "WSDA remains committed to attending to immediate actions that can be taken, as well as long term solutions. We are asking dairy farmers to redouble their efforts to ensure they are protecting clean water that the community, and especially those who farm shellfish, rely upon. Dairy farming is all about managing a multitude of different risks. The tools to manage these risks continue to evolve and improve. We will continue to work with dairies to ensure they collect, store and apply ma-

nure to cropland as a crop fertilizer in a manner that does not result in pollution."

George J. Boggs, Executive Director, Whatcom Conservation District stated "Fecal coliform is a dangerous type of bacteria and is why over half of your Conservation District's resources are devoted to providing technical and financial assistance to livestock owners. We urge all livestock owners who do not have a conservation plan that guards against manure runoff to call (360) 354-2035 x 5. Please schedule a confidential risk assessment by one of our experienced resource planners. Work with us as a responsible community member to rid fecal coliform from our creeks, rivers and shellfish harvest areas. We know, can and should do better." Mr. Boggs also noted that you can see how much


"We're extremely concerned about the decline in water quality in the growing area," said Jerrod Davis, Director of the Washington State Department of Health's Office of Shellfish and Water Protection. "We'll continue working with our partners to find and fix sources of pollution in the watershed."

Jack Louws, Whatcom County Executive said "I am very concerned about the deterioration of water quality in Portage Bay. I have incorporated additional water resource staffing and programs into the upcoming County budget to help restore our waterways to safe and healthy conditions. We, as a community, came together to tackle this problem before, and I'm confident we can do it again."

## Victims of Crime

The Bill Gates Foundation (BGF) had funded a program called "Housing First" for Lummi Victims of Crime (LVOC) November 2011 for almost three years. The BGF has been researching how beneficial it is for families who have been homeless as a result of Domestic Violence or are at risk of being evicted as a result of Domestic Violence to have assistance to get into more permanent housing. LVOC had four transitional houses with clients with families that were living in LVOC shelter that has also been a part of this study. The study is meant to assist families to get into their own home and maintain that home and to learn of what some of the barriers might be into getting their

own home and maintaining their home. Some of the criteria for receiving assistance were to insure that the survivors were able to sustain their housing so we looked at income verification, assessed if other services by LVOC were useful such as legal services and counseling services for the family.

The first two months of the program was learning what the program was about and how the funding could be spent. The beauty of the program was that it could be spent in any way necessary for a survivor to have a home. In 2012 the LVOC Housing First began assisting survivors of domestic violence. The program was used to assist survivors in many ways. Some funding was used to assist families with deposit and first month rent. LVOC

was able to work with Lummi Housing and private landlords to assist families get into their home. Housing first has also assisted families by paying for water bills left by previous relatives, purchasing home items such as beds; kitchen ware; bedding; or storage.

Some of the barriers for the survivors to get into their own home were not having enough money to pay for the damage deposit and first months rent. Some families had no income and were unable to maintain their housing. For families to get into tribal housing some of the barriers was the fact that the parent may be enrolled in a different tribe and the children were enrolled Lummi or the parent was enrolled and the children didn't have the blood quantum to enroll. For some of

the survivors the barrier was criminal history for assault. Some survivors have returned to the family home.

The Housing First program has received 163 applications requesting assistance. 116 families have been assisted. 47 families have not received assistance because they returned to the offending partner or they were not sustainable or simply moved to some unknown location. During this time period the majority of the survivors have continued to live in their home. A very small amount returned to their partner and relinquished their housing.

The Housing first program has been a successful program for LVOC. We have been able to assist a lot of families. Some of the

families receive ongoing services for transportation to therapy. Therapy is important to help the families heal from domestic violence; learn what Domestic Violence is and where to go for help. LVOC has two conferences a year to help educate our community regarding Domestic violence, Child abuse and Sexual Assault. Recognizing Domestic Violence and knowing where to get help is crucial for survivors and this is one of the areas that LVOC helps is by educating the community about Domestic Violence.

It is unfortunate that all the funding for this Housing First program has come to an end but it is also great the LVOC has been able to offer assistance so many of our people who might be homeless.

## Long-range Planning Initiative

### Updating the Lummi Nation's Planning Process

#### Nation-Building Planning Scheduled for 2015

The Lummi Planning Department will be developing and implementing a series of long-range strategic planning initiatives in 2015. These initiatives will be in support of Economic Development, Sche lang en, and the Health and Wellness priorities adopted by the LIBC, as well as the Visions outlined in the Lummi Community Plan.

The first objective will be to develop a Lummi Nation Capital Facilities Plan, which is a detailed list, including timing and funding provisions of major infrastructure and nation-building projects that will meet the needs of the Lummi

Community throughout the next decade or longer.

A second objective will be to develop a Strategic Plan, which will be the clear guidance and response to the Lummi Nation Community Plan, developed in 2005, updated in 2010, but not fully realized in implementation.

Next, the Lummi Nation Comprehensive Land Use Plan, providing policy and guidance for future land use development will be developed. This plan has been mandated as a planning goal by Title 15 since 2004.

Finally, the Nation will update the Reservation Master Plan, providing clear and complete guidance for when, where, and how future development of the Reservation will pro-

ceed through 2026.

These four planning components will provide the means for development of the "Three Villages" concept, which will include the visions for the Kwina, Xwelomeles (Gooseberry Point), and Salish (the I-5 Corridor) Villages sub-areas.

To do this, we will reach out and communicate with the community to listen to and collect your visions for these plans, provide alternatives and report back to you. We plan a series of public meetings, forums and presentations throughout the coming year.

In the first quarter of 2015, we will focus on the sub-area plans (Kwina, Gooseberry and I-5), along with the Capital facilities segment. These efforts

will build into the Strategic Plan, Reservation-wide Master Plan and Comprehensive Land Use Plan in the second quarter.

In the third and fourth quarters, we will consolidate all of the community's visions and collaboration to bring all four plans and three sub-area proposals into alignment.

This large and complex coordination of planning documents, policy and visioning is an important and long-overdue undertaking, vital to the prosperity and wellness of the Lummi people and the sovereignty of the Nation. To achieve it, we need the support, participation and commitment of the entire community.

The Lummi Planning Commission will be hosting between 12 and 16 commu-

nity meetings in the coming year, an ambitious schedule that will require the vision, will and commitment of the people almost as much as that of the leadership and staff of the LIBC.

The first such meeting will be scheduled mid-January and will be announced in the December Squol Quol. We plan to host these events in a number of settings and time, allowing all to participate, regardless of their schedule. In all meetings dinners will be served and activities for the whole family will make them easy to attend.

Stay informed and be prepared to participate in the Long-range Planning Initiative.

## Diana Phair Named Housing Director Of The Year

Diana Phair of the Lummi Nation Housing Authority was named the Northwest Indian Housing Association's Tribal Housing Director of the Year in a ceremony held on Wednesday, September 10 at the Great Wolf Lodge in Grand Mound, WA.

NWIHA holds its Annual Awards Banquet at its September Quarterly Meeting. Diana Phair is one of the longest-serving Executive Directors in all of Indian country. She also was selected to serve on the Negotiated Rulemaking Committee – and served as an alternate during the prior round of Negotiated Rulemaking. Diana is known for being a strategic thinker – and relentless. Through her efforts at her housing authority, she created a number of social programs to support residents and help preserve

the integrity of the Lummi Nation community. Her tribe was the first to take advantage of the Low-Income Housing Tax Credit (LIHTC) program; they built 24 homes through the program in 2000. Currently, they are in the process of transitioning these homes out of the initial 15-year rental program. Finding innovative ways to increase tribal homeownership is a priority for Diana and the Lummi Housing Authority.

Numerous other development programs have made the Lummi Housing Authority a stand-out in tribal housing, including the Kwina Village Apartments (the first on the Reservation), new single-family subdivisions in the Mackenzie Neighborhood, a neighborhood Gym at Mackenzie, and a mixed-use residential development at a site known

as Turkey Shoot.

Congratulations to Diana! Nobody deserves it more.

## Housing Authority Wins Repair and Rehab Grant from USDA

### The Award

The Lummi Nation Housing Authority (LNHA) has been informed that it will receive over \$54,000 in grant funds from the US Department of Agriculture to carry out Repair and Rehab for Very-Low Income tribal families under the USDA Housing Preservation Grant (HPG) Program for 2014. The HPG grant will be used by the Housing Authority to augment

its repair and rehab program, specifically for the most needy segment of the tribal population--- those making less than 50% of the median income for this area. The USDA awards a single grant state-wide under the HPG program on a competitive basis, and the Housing Authority has been successful in competing for the HPG funds in two of the last three grant cycles.

### Repair and Rehab Services

The LNHA will leverage the HPG funds with other funds of the Housing Authority to provide repair and rehab benefit to 24 Very-Low income tribal families. Repair and Rehab activities may include roof replacement and repair, window and door replacement, foundation repair, flooring replace-

ment and repair, fireplace conversions, replacement of fixtures and appliances, insulation replacement and a variety of ADA remodels.

Getting on the Repair and Rehab Waiting List

The HPG Repair and Rehab program is for tribal families living in NON-HUD housing on the Reservation. If you think you may qualify for assistance under this program, the

very first step is to get yourself on the Housing Authority Repair and Rehab Waiting List. In order to do that you will have to fill out an application that you can obtain by contacting Debbie Hillaire or Christina Solomon at the Housing Authority offices at Kwina Road and Haxton Way, 2828 Kwina Road; 360-3412-8407; debbieh@lha-lummi.com or christinas@lha-lummi.com.

## Would you like to own your own home?

### Can you Qualify?

Very shortly--- in fact, right now--- there are homeownership opportunities available through the Lummi Nation Housing Authority for families that qualify. And if you think your income is too low to qualify for a bank loan, or too high to qualify under a Low-Income Housing program perhaps you should think again. Sandy Finkbonner, Mortgage and Investment Analyst at the Housing Authority offices at Haxton and Kwina, would very much like to talk with you about your chances for homeownership.

Using various combi-

nations of HUD money and non-HUD resources, Sandy is most especially looking for way to help families who may be "over-income" but are not "over-income" enough to qualify for a conventional home loan. The Housing Authority is targeting this group because it feels that increasing homeownership is key to building community on the Lummi Reservation. Just ask the 16 new homeowners who have recently moved into their new homes in the Mackenzie Neighborhood how they feel about being homeowners and how they like the deal they got.

### Current Opportunities

The Housing Authority currently has 14 additional build-ready lots in the Mackenzie Neighborhood that could be built upon by new tribal homeowners. In the near future, 18 more build-ready lots will be constructed in accordance with a Master Plan for the expansion of the Mackenzie Neighborhood, which will provide additional opportunities for homeownership.

### Future Opportunities

In addition to the Mackenzie Neighborhood, the Housing Authority is currently constructing 12 build-ready single-family lots as part of a larger mixed-use residential

neighborhood at Turkey Shoot. These 12 lots are also being targeted for homeownership, providing additional opportunities for tribal families.

Besides the build-ready lots that the Housing Authority intends to construct over the next few years, the homeownership programs are also applicable to home construction loans for private properties, or even off-reservation property purchases. Simply stated, there are a variety of ways that tribal families might be able to qualify for a loan and build a home. But you have to APPLY first!

### First Step – Getting on the Homeownership

### Waiting List

The first step in determining if you have a chance to qualify for homeownership is to fill out an application, submit it to the Housing Authority, and get yourself on the Homeownership Waiting List. This is critical, as Housing cannot even review your circumstances unless you are on the Waiting List. 









The Lummi Nation Housing Authority will soon be winding up construction of the first few buildings of the Kwina Village Apartments expansion project, and will be looking for tenants to fill those units. The expansion will eventually include 42 new apartment units and the buildings will be filled as

they are completed, back to front. The project will also involve the construction of a Laundromat. As you can see when walking by on Kwina Road, the new buildings are somewhat larger than the previous apartments, and have a slightly different look. That is because the units in the expanded portion of Kwina Village generally have more bedrooms than the original phase which con-

tained exclusively 1 and 2 bedroom units. This will allow more families and larger households and will expand considerably the mix of tenants in Kwina Village. As the first true apartment development on the Lummi Reservation, the Kwina Village Apartments have proven wildly successful, particularly because of the location of the development which is within walking distance of


most of the essential tribal services as well as transportation connections.

The days are getting shorter and the nights longer and our buses can take you around the Rez and shopping while keeping you dry from the rain. So, come out and enjoy an easy ride with us. In August we gave 5,149 rides, in and around the Lummi Nation while traveling 9,550 miles, which means Lummi Transit, provided an average of 166 rides each day of the month. We strive to offer a quality service to everyone in the community, and hope that our riders agree.

Lummi Transit is adjusting our Reservation and Ferndale Routes in response to the completion of construction at Smokehouse Rd. and Haxton Way intersection. With substantial completion of the round-a-bout scheduled for October 1, 2014 Lummi Transit will implement route changes. Until the construction is fully completed their maybe be delays of up to 30 minutes going through the intersection, so please be patient with us and our drivers.

### Summary of changes: Reservation Route.

- Reservation Route will now serve the residents of Balch Rd. (now longer will be served by the Ferndale

Route);

- Service will start at 6:10am at the Tiopi Loop then going East towards LIBC;
- Service hours will be at the last stop Silver Reef Casino at 8:41pm;
- Longer stops at Fisherman's Cove to allow for convenient shopping at 7:10am, 8:55am, 10:58am, 12:44pm, 2:20pm, 4:06pm, 6:09pm and last stop at 7:55pm

### Summary of change: Ferndale Route.

- Ferndale Route will no longer serve the residents of Balch Rd as they are served by the Reservation Route;






The mission of Lummi Counseling Services program is to provide education and treatment to Native American families in the area of chemical dependency within a comprehensive outpatient counseling program.
